SHARE OF COST: Due to the expense of organizing a Kueing CCFC kindly asks that exhibitors pay a mandatory share of cost fee of \$25.00 per owner (Not per horse) CCFC members receive a \$5.00 discount and pay \$20.00 per owner. IMPORTANT:

ALL horses must arrive the morning of the kueing Prior to 9-9:30 start time

BEFORE UNLOADING all Exhibitors must have signed a RAPP RANCH RELEASE FORM

All FOALS not in stalls or having there turn in the arena must be in a halter and lead at all times.

No sick animals! Animals displaying contagious illness symptoms will be turned away by the management with no fees refunded.

Please bring your ORIGINAL FHANA/FPS Registration Papers and foal certificates !!

DO NOT LEAVE THE SHOW GROUNDS UNTIL THE END OF THE SHOW UNLESS THE MANGEMENTS SAYS IT'S OK, OR YOU COULD COMPERMISE YOUR HORSES FPS REGISTRATION. horses 3+ for studbook ster, or a repeat who's status has been changed **CANNOT LEAVE** the Kueing site until they have been measured and or DNA tested by the judges. This is done at the judges discretion or the end of the day after the **LAST horse** has been shown. Foals may only leave at after they have been microchipped and after the last filly or colt has gone.

Release of Liability

I acknowledge that horseback riding and related activities is a sport which is inherently dangerous and carries with its risks of injury and damage to not only myself, my horse, but others as well. As such, I knowingly assume all risks of liability known or unknown relating to any horseback or other related activities while at the Rapp Ranch (DBIC). I further release and hold harmless Rapp Ranch (DBIC), their employees and agents for any injuries which I, my horse, or other property suffers as a result of others who are also participating in horseback riding activities at the Rapp Ranch (DBIC).

I hereby release DBIC (hereinafter referred to as Rapp Ranch) from all liability for any act(s) of negligence or want of ordinary care on the part of Rapp Ranch or any of its officers, employees, agents, representatives and assigns. I wave, release and discharge Rapp Ranch, its officers, employees, agents, representatives and assigns from any and all claims of liability for injury or damage to me personally, to my horse or to property arising out of my participation in horseback riding and related activities. This agreement is binding upon executors, my heirs, assigns and I.

DBIC (hereinafter referred to as Rapp Ranch) recommends that all riders wear helmets while on horseback. I am aware that while the failure to wear a helmet can increase the likelihood that I will suffer a serious injury or death from a fall while riding, a helmet cannot assure my safety and that riders wearing helmets have suffered serious injury and death while riding.

I EXPRESSLY WAIVE ANY RIGHT I MAY HAVE UNDER CALIFORNIA CIVIL CODE 1542, WHICH STATES; “A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM MIGHT HAVE MATERIALLY AFFECTED HIS SETTLEMENT WITH THE DEBTOR.”

INITIAL

In the event, that any cause of action in tort, contract, or otherwise, which arises out of this agreement, the Owner or Owner’s parent or guardian shall have no more than Six (6) months from the date any said cause of action or claim arises to proceed with their claim or causes of action. This paragraph is intended to limit any and all statutes of limitation arising pursuant to California Law.

I agree I will indemnify and hold harmless DBIC-Rapp Ranch its officers, employees, agents, representatives and assignees against all claims, demands, and causes of action, including court cost and actual attorney fees, arising from any proceeding or lawsuits brought by or prosecuted for my benefit, in which this release is upheld.

Rapp Ranch (DBIC), employees, agents, representatives and assignees shall not be liable for any damage that may accrue from any cause or as result of fire, theft, running away, state of health, veterinarian, and injury to person, horse or property.

Release and Hold Harmless Agreement

CAREFULLY READ THIS AGREEMENT BEFORE SIGNING:

I acknowledge the inherent risks involved in mounting, riding, walking, boarding, jumping, feeding and working around horses, which risks include bodily injury from using, riding or being in close proximity to horses, among other risks and further that both horses and rider can be injured in normal use or in competition or in schooling. I expressly assume any and all risks inherent in all horse related activities including, but not limited to, bodily injury or physical harm or death to horse or rider or spectator.

In consideration for the privilege of riding and/or working around horse in connection with DBIC/Rapp Ranch, 100 Rapp Lane, Napa California, as well as the Property Manager, including, without limitation, DBIC/Rapp Ranch owners(s), teachers(s), trainer(s), employee (s), staff and agent(s) (collectively referred to as DBIC/Rapp Ranch), I agree to hold harmless and indemnify DBIC/Rapp Ranch and further release DBIC/Rapp Ranch from any liability or responsibility for accident, damage, injury or illness to me, to any horse owned by me or my family, and to any family member or spectator accompanying me at or in connection with DBIC/Rapp Ranch. I agree to hold harmless and indemnify DBIC/Rapp Ranch from all claims of injury or loss, whether or not the claim resulted, directly or indirectly, from the negligent acts or omissions of the facility. I agree to indemnify and hold harmless DBIC/Rapp Ranch from and against any and all loss, costs, or expenses or claim thereof whatever nature, arising out of my activities at or in connection with DBIC/Rapp Ranch.

I ACKNOWLEDGE THAT I HAVE READ, UNDERSTAND AND AGREE TO EACH OF THE PROVISIONS IN THE RELEASE AND HOLD HARMLESS AGREEMENT.
